### **ANALYSIS: DISTRIBUTION**

- 241 Service orders
- 120 Dig Alerts (USA's)
  - 8 Fire Flows
- 25 Meters Replaced
- 28 Valves and Hydrants were maintained
- 3 New Services were installed
- 2 Mainline leaks
  - Water Loss of 96,455 Gallons
- 34 Service Line leaks Water Loss of 114,952 Gallons

## CIRP

Tilford pipeline is 100% completed with a total of 29,585' of 8" C909 PVC pipe replaced. 89 services installed with a total of 1900' of 1" copper. 4 -2" air vacs installed to help with air release and surge protection. 32 new fire hydrants were installed with new 6" C909 PVC connections, this means this area is now compliant with the fire protection code for San Bernardino County. 82 new valves have been installed to better isolate any possible issues in the future to limit customer outages. The old main has been severed and the new main connected to the surrounding area. All old jones heads and District infrastructure has been removed. All roads have been finished grading.

As stated in the newsletter the district lost 5.9M gallons in this area from failing infrastructures like main leaks, and countless hours. That is now in the past and the district is moving in the right direction to improve not only the quality of water but save our precious resource. The new excavator arrived last Thursday, and we hope to have the new Pettibone early next week. CIRP has begun Surveying Tilford 2 in-house, to save money. We are still waiting on Material to begin that job. In the meantime, CIRP will push Meter replacement and begin grading the D1-1 booster project.

### PRODUCTION

Steve and Jeremiah took a field trip to the City of Los Banos to watch a test pilot revolved around Chromium 6. Aqua Metrology Systems invited us to have a comprehensive look at their Safeguard H2O Pilot. The district has kept a close eye on the State's regulations revolving around Chromium 6 doing our homework and gathering information so we can not only be proactive but have a comprehensive plan in place for if and when these regulations will be changed. All five of our production wells would ultimately be affected if the regulation changes.

Well 14 has been providing the brunt of our water production now running without problems. This allows for our other two big producing wells to have a break so to speak while 14 handles the water demand. Ultimately this is a cost saving to the district by only having one well run for the majority of the time rather than all three.




